


Government of Macao Special Administrative Region Statistics and Census Service

- A total of 276 MICE events were held, bringing 304,000 participants and attendees, up significantly by 20% and 50% year-on-year. Total floor area used reached 223,000 m². There were 263 meetings and conferences, with 81% being participants of conferences and corporate meetings.
- Number of attendees to the 13 exhibitions surged by 51% year-on-year to 264,000. The average floor area used per exhibition was 3,605 m².
- Information from 10 exhibition organizers indicated that 247 full-time staff were engaged; moreover, 953 exhibitors participated in the exhibitions setting up a total of 1,371 booths, with an average of 1.4 booths per exhibitor. Professional visitors totalled 5,028, coming mainly from Macao (42%) and Mainland China (27%).




Exhibitors

- Information from 145 interviewed exhibitors indicated that sales of products took up 79% of the revenue, while rental of exhibition booth shared 72% of the expenditure.
- Regarding exhibitors' comments about the MICE venue and services,
 69% were satisfied with the efficiency & attitude of the venue staff,
 68% were satisfied with their language skill.
- However, 19% considered that event promotion and venue facilities needed improvement.

Exhibition Organizers

- Revenue of the interviewed exhibition organizers reached MOP16.22 million, up substantially by 88% year-on-year. Meawhile, Expenditure of the exhibition organizers increased by 9% to MOP37.48 million.
- Revenue of the exhibition organizers came from rental of exhibition booths (52%) and financial support from government or other organizations (47%). Expenditure arose from publicity & public relation (26%); production, construction & decoration services (22%) and accommodation, food & beverages (16%).
