Subsidy Ceiling and Calculation Method

Subsidy ceiling: MOP 3,000,000

Based on actual event performance, the subsidy is subject to a gradual increase, and all increments are cumulative.



Grants are given based on merit and meeting the assessment standards



Subsidy Ceiling and Calculation Method



Basic Funding

MOP 400 per non-local attendee

*or for all attendees if the convention is internationally accredited



Additional Funding

An additional 25% funding is granted per fulfilled conditions

(MOP 100 per condition):

- 1.Engage at least 3 Macao SMEs with total services over MOP 500,000, and each SME contract ≥ MOP 50,000
- 2.Include programmes that enhance "MICE + Tourism" elements
- 3. Attendees¹ from Portuguese-speaking countries ≥ 10%
- 4.International attendees² ≥ 30%
- 5.Contribute to attracting investment or fostering development in Macao or the Guangdong-Macao In-Depth Cooperation Zone in Hengqin

Additional Funding

An additional 75% funding is granted per fulfilled conditions

(MOP 300 per condition):

1.Accredited by the International Congress and Convention Association (ICCA)



2.Professional convention related to Macao's major industries³



- 1. Attendees from Portuguese-speaking countries like Angola, Brazil, Cape Verde, Equatorial Guinea, Mozambique, Portugal, Quinea-Bissau, São Tomé and Príncipe, and Timor-Leste.
- 2.International attendees from outside China
- 3. Professional conventions related to Macao's major industries: conventions mainly focusing on industrial development and technological innovation, and promoting exchanges and cross-domain co-operation among representatives of industry, academia and research institutions.

Exhibitions

Basic Funding

Subsidy for exhibition venue rental in Macao: up to MOP 26 per square meter, maximum 4 days.



Professional exhibition will be granted additional funding of MOP 3,000 per exhibitor from outside Macao.



Additional Funding (for Professional Exhibition¹ only)

Additional Funding

An additional 25% funding is granted per fulfilled conditions

(MOP 750 per condition):

- 1.Engage at least 3 local SMEs with total event spending over MOP 500,000, and each SME contract ≥ MOP 50,000
- 2.Include programmes that enhance "MICE + Tourism" elements
- 3.Exhibitors from Portuguese-speaking countries² ≥ 10%
- 4.International exhibitors³ ≥ 30%
- 5.Contribute to attracting investment or fostering development in Macao or the Guangdong-Macao In-Depth Cooperation Zone in Henggin

Additional Funding

An additional 75% funding is granted per fulfilled conditions

(MOP 2,250 per condition):

A professional exhibition related to Macao's major industries.



A professional exhibition related to Macao's major industries. An additional one-off fixed subsidy of MOP 100,000 is available for: Professional exhibitions in the process of applying for Global Association of the Exhibition Industry (UFI) accreditation

- 1. Professional exhibitions: Professional exhibitions accredited by the Global Association of the Exhibition Industry (UFI); or commercial exhibitions of specific industries or professional fields, primarily targeting domestic and international industry professionals and are generally not open to the public. And their core purpose is to promote industry exchange, showcase new technologies and products, and expand business opportunities.
- 2. Exhibitors from Portuguese-speaking countries like Angola, Brazil, Cape Verde, Equatorial Guinea, Mozambique, Portugal, Quinea-Bissau, São Tomé and Príncipe, and Timor-Leste.
- 3.International exhibitors from outside China.



- Non-public entities serving as the hosts or organisers of conferences and/or exhibitions in Macao
- Including business owners and associations legally established in Macao, or non-public entities legally established outside Macao

Application Deadline and Frequency







Identical events (same type & theme): 2 per year



B2C (business to consumer) events: 4 per year

* Calculated based on the year in which the applications are submitted

Application Method

Submit online via the "Business & Associations Platform" portal/mobile app operated by Public Administration and Civil Service Bureau of Macao SAR.

Submit in person by the applicant or legal representative at IPIM.*

*Applicants may use a valid account in "Event Online Application System" operated by IPIM to complete forms and upload documents.

*The event must take place in a convention/exhibition centre, hotel premises or other professional venues for holding conventions and exhibitions.

*Activities with charity fundraising, social gatherings, award presentations or display as main component are not eligible for the funding.







Subsidy Ceiling and Calculation Method

"Multi-venue Events"

A one-off fixed subsidy is available for events held concurrently in Macao and Guangdong-Macao In-Depth Cooperation Zone in Hengqin, provided that the Hengqin session meets the following criteria:



100–199 attendees: MOP 50,000

200–499 attendees: MOP 100,000

500+ attendees: MOP 150,000

Exhibitions (held for at least 2 consecutive days, open ≥ 6 hours per day):

50–74 exhibitors: MOP 50,000

75–99 exhibitors: MOP 100,000

100+ exhibitors: MOP 150,000
